Bidders, submitting their bid electronically, should deposit following cost of bidding document as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

4. Pre-bid meeting shall be held at **Dhunibeshi Municipality, Dhading** at **1st mangsir 2082 at 1:00 pm**.
5. Electronic bids must be submitted to the office **Dhunibeshi Municipality, Dhading** through PPMO website www.bolpatra.gov.np/egpon or before **12:00** on **12th Mangsir 2082**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00** on **12th Mangsir 2082** at the office of **Dhunibeshi Municipality, Dhading**. Bids must be valid for a period of **90 days** from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of followings amount, which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
